<p>Key Advice for Exam Preparation / Revision</p>	<p><u>USE YOUR EXAM TECH SUPPORT BOOKLET FOR FOCUSED SUPPORT AND MODEL ANSWERS</u></p> <ul style="list-style-type: none"> - Time management - write proportionate to the marks e.g. 12 mark Q - 14/15 mins max - 8 Mark Q - EXPLAIN the law (cases/examples briefly explained where appropriate) - 12 Mark Q - EVALUATE only (see evaluation points and explanations within HW booklet and place within the given Q's) (PDE+ or PDE if struggling) - 20 mark scenario: 8 marks (AO1 - do not explain all cases, briefly explain two and bracket as many as you can), 12 marks (AO2) - relevant AO1, mirrored and precise AO2 - 20 mark essay: 8 marks (AO1) and get that done asap! - PDE+ (12) can do PDE if struggling, need to keep arguments and examples in-line with the essay focus.
